

## **For Therapy<sup>1</sup> Providers<sup>2</sup>**

Therapy providers in the Twin Cities Therapy Network (TCTN) will provide unbiased and ethically based care that is in the best interest of their client/patient/customer (CPC). All services will adhere to the CPCs full and explicit consent, ensuring confidentiality and discretion with all identifying information when interacting with anyone outside the therapeutic relationship<sup>3</sup>.

TCTN requires providers to agree to the following terms and codes of conduct to be featured on the website. To post a provider profile, program, clinic, or event, the service provider agrees to the following code of conduct. Failure to follow results in removal of listing from the TCTN.

### **1. Providers will not:**

- a. **Distribute or administer illegal substances<sup>4</sup> to clients or event attendees.**
- b. **Take payment to work with individuals who self-administer illegal substances with the intent of undergoing 'drug-assisted therapies.'**
- c. **Refer anyone to underground practitioners who administer psychedelics during therapeutic sessions.**
- d. **Partake in any other illegal or unethical actions specified under a professional license.**

2. Providers may withdraw participation at any time.

3. TCTN may remove profiles or listing at any time and for any reason.

## **For (Clients/Patients/Customers - CPC)**

CPCs will not solicit or try to procure any substances or materials that are considered illegal therapies. CPCs will not show up to therapy sessions or events under the influence of illegal substances or with the intention to take illegal substances during the session/event.

## **Maintaining Quality Providers and Services**

To feature high quality providers and service, TCTN takes feedback, both positive and negative, through an online form on the website. If consistent negative feedback is received, we will remove the profile or listing. Reasons for removal could include:

- a. Non-responsiveness or untimely communication of the provider/facilitator with a client
- b. Unsatisfactory therapeutic services
- c. Inappropriate or unethical behavior
- d. Unprofessional public appearance in social media or events
- e. Any other action not aligned with a provider's professional license or terms of service
- f. Breaking terms of the codes of conduct
- g. Any other reason not listed here

<sup>1</sup> Therapy refers to any modality that improves quality of life and promotes wellness through reproducible anecdotal evidence.

<sup>2</sup> Providers are the facilitators of the modality. Providers are required to be licensed in a mental health profession or certified to administer alternative healing modalities (e.g. Acupuncture, Reiki, Craniosacral Therapy, Yoga, etc). We will ask for proof of credentials prior to being added to our network. Anyone without a license or certification to provide services that are offered will not be endorsed as an official provider for the TCTN. After applying, providers are selected based on review of resumes and web searches. Their public appearance (professional website, employment/practice, social media posts, etc.) should be aligned with the mission, values, and ethics of the Psychedelic Society of Minneapolis. Professional references may be collected and contacted as part of the application process.

<sup>3</sup> Therapeutic relationship involves the provider/ facilitators, the CPC, and anyone they discuss or involve as part of their therapeutic process

<sup>4</sup> Illegal substances are any drug, therapy or behavior that is in violation to local and federal law enforcement regulations.

## **Information Collection and Use**

While using our Site, we may ask you to provide us with your name and email address. For example, you may sign up to receive email bulletins or updates about the Site by subscribing with your email address. You may also submit comments or fill out contact forms on the Site. Generally, we do not encourage submission of any personal information in these comments or contact forms other than the required fields (e.g., name and email address). Contact form responses in Provider Profiles go directly to the given Provider; therefore, the information disclosed is subject to the policies and terms of the Provider.

## **How We Collect and Use Information**

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data"). This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics. This information of Site use may be used to make improvements on the Site.

## **Disclosure of Information**

We will not share your name or email address given to the Site to third parties, except:

1. With hired third party service providers (e.g. Mailchimp, these third parties may not keep or use your personal information for any other purpose),
2. When required by legal requirements, such as law, regulation subpoena, warrant, court order, or with regulator or law enforcement agencies, or
3. In the case of a corporate sale, merger, acquisition, dissolution, reorganization, or similar occurrence.

## **Communications**

We may use your Personal Information that you have provided in the opt-in form to contact you with newsletters, marketing or promotional materials.

## **Cookies**

Cookies are small text files with small amount of data, which may include an anonymous unique identifier, that the Site places on your computer's hard drive. Cookies are sent to your browser from the Site to improve and optimize your experience on the Site. Like many sites, we use "cookies" to collect anonymous site traffic information. You can instruct your browser to block all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some features of our Site.

## **Security**

We may update or change our Privacy Policy at any time. You should check this Privacy Policy periodically since we will not send individual notice to you about changes to this Privacy Policy. Your continued use of the Service after we post any modifications to the Privacy Policy on this page will constitute your acknowledgment of the modifications and your consent to abide and be bound by the modified Privacy Policy.
